### \$3,250,000 WIN For Cyclist Injured in Accident with Firetruck Privacy Settlement

#### **REAL CASES, REAL WINS**

When an insurance company offered \$600.000 to settle a serious motor vehicle crash case, attorney John DeGasperis, founding partner of New York Injury Law, said "Not enough."

#### The Case: Bicyclist vs. Fire Truck

John represented a cyclist who was struck by a fire truck making a careless turn in a non-emergency situation. The collision resulted in severe bodily injuries, including traumatic brain trauma-a lifealtering condition with long-term consequences.

Despite the negligence, the insurance company refused to offer fair compensation, hoping John and his client would accept their \$600,000 settlement.

#### The Verdict: A Multi-Million Dollar Win

Instead of settling, John and Keith took the case to trial. The jury saw the truth and delivered a powerful verdict:

• \$1.000.000 for past pain and suffering (covering the two years between the accident and the trial)

• **\$2,250,000** for future damages

Totaling a \$3,250,000 verdict more than 5 times the original offer.

# Apple's \$95 Million Siri

#### **LEGAL NEWS**

Apple has agreed to a \$95 million settlement to resolve a class-action lawsuit alleging that Siri, its voice assistant, recorded and shared users' private conversations without consent. The lawsuit, filed in 2019, claimed that Siri was inadvertently activated, capturing sensitive discussions and sharing them with third parties, including advertisers.

While Apple denies any wrongdoing, the settlement allows eligible users-those with Siri-enabled devices from September 17, 2014, to December 31, 2024-to claim up to \$20 per device, for up to five devices. This case highlights growing concerns about user privacy in voice-activated technologies.

The official settlement website has not been announced yet, but keep an eye out for it if you believe you may have a claim.
