

## From Courtroom to Camera: How John DeGasperis, Esq. Became a Leading Legal Voice on TikTok

powerful. Through consistent, authentic videos—often recorded from his office, building renovation, or even his car—John built a platform that educates the public on personal injury law while showcasing the real-world work of a trial lawyer.

But it wasn't always easy. John's early videos on Facebook and Instagram were modest in reach. The breakthrough came when he recognized that, in addition to being a skilled attorney, he was also comfortable on camera—and he strategically leveraged both strengths to his advantage. "People started noticing the videos, engaging with me about the content, and learning who I was — not just as a lawyer, but as a member of the community."

Despite doubts from some peersand personal hesitations about how lawyers should appear on social media—John leaned in. He hired a creative team to help him improve the quality and consistency of his content. The goal wasn't to chase fame, but to create a new kind of client connection and one rooted in education, trust, and accessibility.

Viral success came in waves:

- A video about New York's marijuana legalization
- A controversial but legally insightful post titled "I Sued a 9-Year-Old ...and Won"
- A public service clip about jury duty that was picked up by comedian Tom Segura
- A popular explainer on **liability** waivers in ski accidents
- And a Facebook class action settlement video with over 10 million views

Each post reflected John's passion for the law and his talent for simplifying complex legal issues. Some sparked debate. Others sparked laughter. All of them sparked learning.

Yet behind every video was real work—settling multi-million dollar cases, leading a growing law firm, and finding balance between career, content, and family. "There were moments when I questioned it," John admits. "But I realized this is bigger than me. It's about showing people that they have rights, that someone is willing to speak up for them, and that being a lawyer doesn't mean hiding behind legalese."

Today, John's TikTok presence has become an invaluable tool—not just for outreach, but for empowering injured New Yorkers to take action.

And through it all, his message remains the same: The law is for everyone. You just need the right person to explain it.



## **Protecting Injured Construction Workers LEGAL NEWS**

From working at heights to handling heavy machinery, construction workers face serious risks every day. Fortunately, New York has some of the strongest labor laws in the country designed to protect those who build our cities.

New York Labor Law Sections 200, 240(1), and 241(6) address safety on construction sites and allow injured workers to hold property owners and general contractors accountable when safety standards are violated.

- Labor Law Section 240(1), also known as the "Scaffold Law," is especially important. It protects workers injured in falls from ladders, scaffolds, and other elevated heights. Under this law, property owners and general contractors can be held liable if proper safety equipment wasn't provided.
- Labor Law Section 241(6) ensures that construction sites follow New York's "Industrial Code" safety regulations. If a violation causes an injury, the worker may have a right to compensation beyond workers' compensation.
